



ESCAPE THE HEAT SWEEPSTAKES

"Immediate family members" includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grandchildren (including step-grandchildren), and each of their respective spouses. How to Enter:

To be eligible for automatic entry, the member must have a personal loan funded by Arizona Central on or between May 1, 2017 and June 30, 2017. The sweepstakes begins May 1st 2017 and ends June 30th 2017 ("Sweepstakes Period").

All entries must be postmarked prior to June 30th 2017 to be eligible for entry and should contain the entrants full name, address, and telephone number and email address.

Prize Information: The winner of this competition will receive a one-time prize of a Get Away Today vacation which includes a 3-day 2-night stay in Anaheim or San Diego, California, two adult 1-day passes to Disneyland or Sea World. They will also receive \$1,000 cash.

Monetary prize will be deposited into winning member's Member Share account within seven (7) to ten (10) business days after the winner is notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form. The vacation package will be mailed to the winning member. In the event of a non-member winning this sweepstakes, both the vacation package certificate as well as a check for \$1,000 will be mailed to the winner after they have been notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form.
