



**“Unpack Your Boxes. Pack Your Bags!” SWEEPSTAKES**

**Eligibility:**

The following individuals are not eligible to be entered in the “Unpack Your Boxes. Pack Your Bags!” sweepstakes drawing of \$1,000 cash prize and vacation package (“Giveaway”): Employees, officers, and directors of Arizona Central Credit Union (“Sponsor”) and or printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this promotion (collectively, “Released Parties”), and the members of the immediate families or households, whether or not related, of any of the above. “Immediate family members” includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grandchildren (including step-grandchildren), and each of their respective spouses. **How to Enter:**

To be eligible for automatic entry, the member must apply and fund a first mortgage loan with Arizona Central Credit Union by October 31, 2017. Offer excludes all home equity loans and lines of credit.

Monetary prize will be deposited into winning members’ Member Share account within seven (7) to ten (10) business days after the winners are notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form. The vacation package will be mailed to the winning members. In the event of a non-member winning this sweepstakes, both the vacation package certificate as well as a check for \$1,000 will be mailed to the winner(s) after they have been

notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form.
