



### **ESCAPE THE HEAT SWEEPSTAKES 2019**

#### **How to Enter:**

To be eligible for automatic entry, the member must fund a personal loan with Arizona Central Credit Union on or between May 1, 2019 – June 30, 2019. The sweepstakes begins May 1, 2019 and ends June 30, 2019 ("Sweepstakes Period").

All entries must be postmarked prior to June 30, 2019 to be eligible for entry and should contain the entrant's full name, Arizona mailing address, telephone number, email address, and a brief description about how they heard about the promotion.

#### **Prize Information:**

One winner of this competition will receive a one-time prize of a Get Away Today vacation package which includes a 3-day, 2-night stay in Anaheim or San Diego, California, with two adult 1-day passes to Disneyland or Sea World. The prize value of the vacation package is valued at \$630. They will also receive \$1,000 cash.

Monetary prize will be deposited into winning member's Member Share account within seven (7) to ten (10) business days after the winner is notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form. The vacation package will be mailed to the winning member. In the event of a non-member winning this sweepstakes, both the vacation package certificate as well as a check for \$1,000 will be mailed to the winner after they have been notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form.

Winners will be selected in a random drawing on or about July 12, 2019, from among all eligible entries received by Arizona Central Credit Union, whose decisions will be final and binding in all matters relating to this Giveaway. Winners will be notified by phone and/or email. Odds of winning will depend on the number of eligible entries received. Prize will be issued within ten (10) business days following the drawing.
