



### **Mortgage + Vacation/\$1K CASH SWEEPSTAKES**

#### **Eligibility:**

The following individuals are not eligible to be entered in the sweepstakes drawing of the Get Away Today vacation and \$1,000 cash grand prize ("Giveaway"): Employees, officers, and directors of Arizona Central Credit Union ("Sponsor") and or printers, advertising and promotion agencies, and any and all other companies associated with the design or execution of this promotion (collectively, "Released Parties"), and the members of the immediate families or households, whether or not related, of any of the above. #### **How to Enter:**

To be eligible for automatic entry, the member must apply for a first mortgage loan with Arizona Central Credit Union between April 1, 2019 and May 31, 2019, and fund by July 31, 2019 with Arizona Central Credit Union. Offer excludes all home equity loans and lines of credit.

As an alternative method of entry, entrant must submit entrant's name, Arizona mailing address, zip code, age, e-mail address, day and evening telephone numbers and a brief description about where they heard about this promotions on a 3" x 5" card mailed to: Mortgage + Vacation/\$1K Cash Sweepstakes, Arizona Central Credit Union, Attn: Marketing, P.O. Box 11650, Phoenix, AZ 85061-1650. All entries must be postmarked prior to May 31, 2019 to be eligible for entry. Limit one entry per person per Arizona household mailing address.

#### **Prize Information:**

The winner of this competition will receive a one-time prize of a Get Away Today vacation which includes a 3-day, 2-night stay in Anaheim or San Diego, California, and two adult 1-day passes to Disneyland or Sea World. The prize value of the vacation package is valued at \$630. They will also receive \$1,000 cash.

Monetary prize will be deposited into winning member's Member Share account within seven (7) to ten (10) business days after the winner is notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash winnings will be considered as interest and will be reported on the appropriate tax form. The vacation package will be mailed to the winning member. In the event of a non-member winning this sweepstakes, both the vacation package certificate as well as a check for \$1,000 will be mailed to the winner after they have been notified and approved by the Arizona Central Credit Union Marketing department. The \$1,000 cash

winnings will be considered as interest and will be reported on the appropriate tax form.

Winner will be notified by phone and/or e-mail. Odds of winning will depend on the number of eligible entries received. Prize will be issued within ten (10) business days following the drawing.
